HAZE. GALLERY OPEN CALL FOR RESIDENTS 2024

HAZE.GALLERY is excited to invite emerging artists to participate in our open call for potential representation, special collections, and exhibition opportunities in 2023/2024! We are eager to review your submissions and explore the possibility of collaborating with you in the future.

As an online gallery and curatorial platform, HAZE.GALLERY aims to provide a dynamic and inclusive space for artists to showcase their work to a global audience. We are committed to supporting emerging talent and fostering meaningful connections between artists and art enthusiasts.

Information and eligibility

- Artists must be 18 years or older and working in any medium. The submitted artwork should be currently available for sale and priced between 500-7000 EURO retail value.
- While having a fine arts degree is appreciated, it is not essential to participate in our open call. We welcome artists from around the world, so you do not need to be based in EUROPE to apply.
- If your artwork is selected, please note that we primarily work on consignment. We expect that the specific artworks chosen will not be booked for exhibitions with other galleries for a period of six months (unless they are chosen solely for an online show/collection with our gallery). This timeframe is flexible and will be agreed upon with each artist's approval. If your work is selected, our curator will contact you for additional information and images. You will also be asked to sign a standard gallery/artist contract.
- Artists are not required to submit only works that are currently available for sale. We encourage you to show us your best work. However, we will only exhibit art that can be purchased.
- Gallery artists should provide high-quality photographs of each artwork that will be featured on our website. These photographs should include images of the sides and details, ensuring that potential buyers have a complete visual representation of your piece. While not mandatory, we prefer if you also have video content of your artwork.
- On any works sold through our platform, the gallery will charge a 30% commission, and the artist will receive 70%. The gallery commission should not be added to the artist's normal selling price.
- The buyer of the artwork will be responsible for covering the shipping costs, which will be calculated based on weight and the intended destination.
- Artists will be responsible for properly packing the sold artwork according to our specific instructions and industry standards, as well as taking it to a postal location.

- Artwork will be sold as-is, with no refunds. Therefore, it is crucial to provide accurate, high-resolution images of your work. Once the buyer receives the piece, payment will be made to the artist.
- All art will be insured during shipping to protect both parties.
- Works are generally offered unframed unless it is a part of the piece or requested by the buyer. In the latter case, we will coordinate the extra costs with the client.

PLEASE PREPARE THE FOLLOWING FOR YOUR APPLICATION:

- * Artist Statement and Artist Biography as a Word Document
- * Artist Resume
- * Up to ten (10) images of completed artworks
- * Please submit only jpg files
- * Images should be no more than 1-3 MB in file size
- * File Name: Images should be titled in the following manner: First Name-Last Name-Title (For example: Jane-Doe-Title; Jane-Doe-Title; etc.)
- * Annotated Image List: Title of work, Dimensions, Medium, Year of Completion, Price
- * A non-refundable submission fee of 35 EURO for up to ten images is required.

We will continue to review applications on a rolling basis until the deadline of December 31st, 2023.
